**Seasonal Residents** whose primary address is not New London must fill out a [Nonresident Affidavit](#)

**If you want to transfer your plates**, bring your original registration not your plates.

**NOTE:** You can only transfer credits if the primary (first) driver remains the same.

**Payments** accepted are cash, check or credit card (plus 2.99% convenience fee, \$2.50 min).

## Bill of Sale requirements for trailers

Pursuant to [RSA 261:148, III](#), a Bill of Sale for a motor vehicle must include the following information:

- Date of the sale.
- A detailed description of the vehicle, including:
  - Vehicle identification number - VIN
  - Year, Make & Model
  - Gross vehicle weight rate (GVWR)
  - Manufacturer suggested retail price (MSRP)
- Name, signature and legal address (no PO Box) of purchaser.
- Name, signature and legal address (no PO Box) of seller.
