The following materials **will not be accepted** at the Town of New London Waste Facilities:

- HAZARDOUS WASTE (check for locations <https://hhw.uvlsrpc.org/>)
- MEDICAL WASTES
- ASBESTOS
- PAINTED WOOD
- BUILDING CONSTRUCTION DEBRIS
- NO ACETILINE
- NO OXYGEN

If you use the Transfer Station and are discovered to be disposing of prohibited or non-New London residential materials, your actions will be reported to the regulatory agency of the State of New Hampshire Solid Waste Program. In addition, you will be required to pay for all costs associated with the clean-up, transport and disposal of prohibited wastes to a facility of our choice. You may also lose future Transfer Station disposal privileges. The Town of New London reserves the right to revoke waste dumping privileges at any time.
